WHEREAS, Declarant has changed the name of the Property from Pelican's Nest to Pelican Landing and desires to additionally hereby amend the Declaration for that purpose.

NOW THEREFORE, in consideration of these premises and the herein contained, DECLARANT hereby amends the covenants Declaration by deleting any and all reference to the name Pelican's Nest and replacing it with Pelican Landing and by deleting any and all reference to the name PN and replacing it This amendment shall run with the land and be by all with PL. parties having any right, title or interest in the Property or any part thereof, their successors and assigns, and shall inure to the benefit of each owner thereof.
