## FIRST AMENDMENT TO THE AMENDED AND RESTATED SIXTH SUPPLEMENT TO THE

## DECLARATION AND GENERAL PROTECTIVE COVENANTS LOTS 1 THROUGH 34, PELICAN LANDING (A REPLAT OF PELICAN LANDING UNIT SIX)

THIS FIRST AMENDMENT is made this 15 day of December, 1993, by WESTINGHOUSE BAYSIDE COMMUNITIES, INC., a Florida corporation, and joined by WESTINGHOUSE COMMUNITIES OF NAPLES, INC., a Florida corporation ("WCN"), to modify that Amended and Restated Sixth Supplement to the Declaration and General Protective Covenants recorded in Official Records Book 2315, Pages 4339-4350, inclusive, of the Public Records of Lee County, Florida ("Supplement"). All defined terms used herein shall have the same meaning as given in the Supplement.

## WITNESSETH:

WHEREAS, DECLARANT has recorded the Amended and Restated Declaration and General Protective Covenants for Pelican Landing (hereinafter referred to as DECLARATION) at Official Records Book 2198, Pages 1873 through 2026, inclusive, of the Public Records of Lee County, Florida, as amended; and

WHEREAS, the Supplement provides in Article III, Section 3 that "The DECLARANT may, in its sole discretion, modify, amend, delete, waive or add to this SUPPLEMENT or any part thereof. The power of amendment, however, shall be limited to modification or enlargement of existing covenants which provision shall not substantially impair the general and uniform plan of development originally set forth herein"; and

WHEREAS, DECLARANT and WCN wish to delete certain restrictions imposed upon LOTS 31-34 of the NEIGHBORHOOD, as set forth herein, which provisions shall not substantially impair the general and uniform plan of development for the NEIGHBORHOOD.

NOW, THEREFORE, DECLARANT hereby amends the Supplement as follows:

- 1. A new subparagraph f. is hereby added at the end of Section 2 of Article II to read as follows:
  - "f. The foregoing subparagraphs a. through e. of this Section 2 shall not apply to LOTS 31-34, inclusive".
