WHEREAS, it is the further intent of DECLARANT that the property described herein become a part of an area being developed by DECLARANT known as THE COLONY AT PELICAN LANDING, which has its own Declaration and General Protective Covenants; and

NOW, THEREFORE, DECLARANT hereby declares that the real property described in as Sites 2 through 6, inclusive, Pelican Landing Unit Twenty-five, according to the plat thereof recorded in Plat Book 58, Pages 83 and 84, of the Public Records of Lee County, Florida, shall be held, transferred, sold, conveyed and occupied subject to the DECLARATION excepting therefrom ARTICLE XI, <u>ARCHITECTURAL STANDARDS</u> and ARTICLE XII, <u>USE RESTRICTIONS</u>.
