WHEREAS, the 56th Supplement pertains to that certain Amended and Restated Declaration and General Protective Covenants for Pelican Landing recorded in Official Records Book 2198, page 1873, Public Records of Lee County, Florida (the "Pelican Landing Declaration"); and

WHEREAS, the intent of the 56th Supplement was to subject the lands described therein (the "Lands") to the provisions of the Pelican Landing Declaration and impose additional restrictions upon the Lands; and

NOW THEREFORE, in consideration of the foregoing, the Declarant hereby amends the 56th Supplement as follows:

1. Paragraph 1 on page 3 of the 56th Supplement is hereby deleted in its entirety and replaced by a paragraph which reads as follows:

The PROPERTY may be used only for a commercial project consisting of a maximum of four (4) buildings with up to a maximum total of Fifteen Thousand (15,000) square feet of office space and only in accordance with CPD ZONING. No structures shall be erected or placed in or on any lakes or water management areas in or adjacent to the PROPERTY without the prior written consent of the DECLARANT.

2. The reference to the Certificate of Authority/Power of Attorney on page 14 of the 56th Supplement is hereby deleted in its entirety and replaced with the following language:
