EXHIBIT "A" AMENDMENT TO AMENDED AND RESTATED DECLARATION AND GENERAL PROTECTIVE COVENANTS FOR PELICAN LANDING

New language indicated by underlining.

The seventh paragraph of Article X, Section 1 is amended as follows:

Until termination of the Class "B" Control Period or until such earlier time as Declarant in its sole discretion shall determine, in lieu of paying Common Assessments on its unsold Units, Declarant shall be obligated for the difference between the total amount of Common Assessments levied on all Units and Business Properties subject to assessment and the amount of actual expenditures required to operate the Association during the fiscal If Declarant determines not to pay the difference between vear. the amount of Common Assessments levied on all Units and Business Properties subject to assessment and the actual expenditures, then Declarant shall pay assessments as any other Member pays for Units and portions of the Business Properties it owns. This obligation may be satisfied in the form of a cash subsidy or by "in kind" contributions of services or materials, or a combination of these. Notwithstanding anything provided herein, Declarant shall not be responsible under any circumstances to fund any portion of reserve contributions. The phrase "subject to assessment" in this paragraph shall be interpreted by reference to the date of commencement of assessments for Units in Article X, Section B. It is the intent hereof to confirm the original intent of the drafter of this paragraph.
