CERTIFICATE OF AMENDMENT TO AMENDED AND RESTATED DECLARATION AND GENERAL PROTECTIVE COVENANTS FOR PELICAN LANDING

This Certificate of Amendment is made this $\frac{29}{200}$ day of <u>JANUAR</u> 2002, by WCI Communities, Inc., a Delaware corporation, successor by merger of WCI Communities Limited Partnership, successor by merger of Pelican Landing Communities, Inc. (f/k/a Westinghouse Bayside Communities, Inc. (the "Declarant").

WHEREAS, Declarant recorded that certain Amended and Restated Declaration and Protective Covenants for Pelican Landing on January 18, 1991, in O.R. Book 2198, Page 1873 et seq., of the Public Records of Lee County, Florida, as amended (the "Declaration"); and

WHEREAS, Declarant recorded that certain Forty-seventh Supplement to the Amended and Restated Declaration recorded in O.R. Book 2725, Page 3268, of the Public Records of Lee County, Florida ("Supplement"), which Supplement subjected certain real property in Lee County, Florida to the provisions of Declaration, including property being operated as a golf course, more particularly described in Exhibit "A" attached hereto (hereinafter referred to as the "Golf Course Parcel"); and

WHEREAS, Declarant conveyed certain real property in Lee County, Florida, including the Golf Course Parcel, to Pelican Landing Golf Resort Ventures Limited Partnership ("Golf Resort Ventures")and Pelican Landing Timeshare Ventures Limited Partnership ("Timeshare Ventures"), as tenants in common, by Warranty Deed, dated December 16, 1998, recorded in O.R. Book 3052, Page 1748 ("Warranty Deed"); and

WHEREAS, Declarant entered into that certain Post Closing Agreement, dated December 16, 1998, as amended, between Declarant and Golf Resort Ventures and Timeshare Ventures ("Agreement"), which provided that upon partitioning the land described in Warranty Deed (including the Golf Course Parcel) between Golf Resort Ventures and Timeshare Ventures, the Golf Course Parcel would be released from the provisions of the Declaration by a document that also would prohibit the Golf Course Parcel from ever being annexed into and subject to the provisions of the Declaration in the future without the written consent of the owner of the Golf Course Parcel; and

WHEREAS, the land described in the Warranty Deed was partitioned by virtue of those certain Warranty Deeds, dated November 13, 2000, recorded in O.R. Book 3331, Page 3739 and O.R. Book 3331, Page 3742, and further partitioned by that certain Warranty Deed, dated December 10, 2001, recorded in O.R. Book 3539, Page 3111, and those certain Quit Claim Deeds, dated December 10, 2001, recorded in O.R. Book 3539, Page 3116 and O.R. Book 3539, Page 3120, all of the Public Records of Lee County, Florida.

WHEREAS, Golf Resort Ventures is the owner of the Golf Course Parcel and its general partner is Pelican Landing Golf Resorts, Inc., a Delaware corporation, which is a wholly owned subsidiary of Declarant; and

WHEREAS, Article VIII, Section 4 of the Declaration provides that" Declarant has the right to amend this Declaration at any time, and with the approval of no other Person being required, so long as it holds an unexpired option to expand the community pursuant to this Article VIII, without prior notice and without the consent of any Person, for the purpose of removing certain portions of the Properties then owned by Declarant or its affiliates or the Association from the provisions of this Declaration to the extent originally included in error or as a result of any changes whatsoever in the plans for the Properties desired to be effected by Declarant, provided such withdrawal is not unequivocally contrary to the overall, uniform scheme of development for the Properties, as determined by Declarant"; and

WHEREAS, Declarant desires to withdraw the Golf Course Parcel from the provisions of the Declaration and the jurisdiction of the Pelican Landing Community Association, Inc. and to memorialize in this document that the Golf Course Parcel shall never be re-subjected to the provisions of the Declaration in the future without the written consent of the owner of the Golf Course Parcel.

NOW THEREFORE, the Declarant hereby amends the Declaration to delete the Golf Course Parcel from the legal description attached as Exhibit "B" to the Declaration, thereby removing the Golf Course Parcel from the provisions of the Declaration and from the jurisdiction of the Pelican Landing Community Association, Inc. and this amendment is hereby adopted in the form attached hereto, and made a part hereof.

AMENDED AND RESTATED DECLARATION AND GENERAL PROTECTIVE COVENANTS FOR PELICAN LANDING

1. Article I, Section 24, is hereby amended to delete the real property described in Exhibit "A" attached hereto ("Golf Course Parcel") from the legal description attached as Exhibit "B" to the Declaration, thereby removing the Golf Course Parcel from the provisions of the Declaration, and from the jurisdiction of the Pelican Landing Community Association, Inc.

2. Declarant hereby prohibits the Golf Course Parcel from ever being annexed into and becoming subject to the provisions of the Declaration in the future without the written consent of the owner of the Golf Course Parcel.
