## **QUIT CLAIM DEED**

THIS QUIT CLAIM DEED executed this Deep day of March. 2004 by WCI COMMUNITIES, INC., a Delaware corporation, whose address is 24301 Walden Center Drive, Bonita Springs, Florida 34134, joined by PELICAN LANDING COMMUNITY ASSOCIATION, INC., a Florida not-for-profit corporation, whose address is 24501 Walden Center Drive, Bonita Springs, Florida 34134, as Dedicatee under that certain dedication of Tract D, Pelican Landing Unit Four, according to the plat thereof recorded in Plat Book 49, Pages 1 through 4, inclusive, of the Public Records of Lee County, Florida (collectively, the "Grantors"), to BAYSIDE IMPROVEMENT COMMUNITY DEVELOPMENT DISTRICT, an independent special district of the State of Florida established under Chapter 190 Florida Statutes, whose address is 210 N. All of Tract "A" (Common Area and Utility Easement) and Tract "D" (Water Management, Conservation and Common Area), Pelican Landing Unit Four, according to the plat thereof, recorded in Plat Book 49, Pages 1 through 4, inclusive, of the Public Records of Lee County, Florida, LESS AND EXCEPT that portion of Tract "D" replatted as part of Pelican Landing Unit Twelve, according to the plat thereof recorded in Plat Book 51, Pages 39 through 42, inclusive, of the Public Records of Lee County, Florida.

TO HAVE AND TO HOLD the same together with all and singular the appurtenances thereunto belonging or in anywise appertaining, and all the estate, right, title, interest, lien, equity and claim whatsoever of the said Grantors, either in law or equity, to the only proper use and benefit of the Grantee forever.
